Plan members will also benefit from zero deductibles, no copays, and free health risk assessments with lab work for evaluation of cholesterol, blood sugar, liver function, blood pressure and other bio-metric panels.

"An increasing number of private employers and governments are launching employee health centers to lower health costs by improving care, enhancing disease management, and providing easier access to care," said Ray Tomlinson, president of Crowne Consulting Group.

In addition to corporations and governments, school districts are becoming self-insured and offering worksite care to save money for both employees and their districts.
